In the case of joint holders of any share, any one of such holders may vote at the meeting, either personally or by proxy, in respect of such share as if he were solely entitled thereto, but if more than one of such joint holders be present at the meeting personally or by proxy, the holder whose name stands first in the register of members of the Company shall alone be entitled to vote in respect of that share. To be valid, this form of proxy and the power of attorney or other authority, if any, under which it is signed or a certified copy of that power or subtority much be detected up to the company shall alone be entitled to vote in respect of that share.
